## 2. Advantage of the full digitization of documentation processes

We start with changes in organizational procedures and the introduction of the paper-reduction policy. This approach may generate some savings, but has a limited impact on process optimization. The next stage includes working

on electronic documents. However, this solution does not eliminate the costs associated with printing and archiving, which often may seem necessary due to existing legal requirements. That is why the full digitization of the process of creation and circulation of documentation proves to be the most advantageous solution, allowing to achieve the highest level of improvement of business processes.

## 3.1. Stages of the project of digitization of documentation processes

- Analysis of the current architecture of IT processes in the organization and outline of a plan for its optimization, guaranteeing customer satisfaction, security and data integrity
- Getting acquainted with the legal regulations that the organization must comply with and determining the scope of changes that meet the quality requirements in the industry
- Proposal of a technological solution that is a response to the identified needs
- Design of a „paperless“ organization model and development of a detailed work schedule
- Performing the digital transformation of the organization, including the migration of data from other systems
- Specialist support during the transition period and maintenance of computer systems

## 3.2. Development of the digitization process model

When working on a document digitization project, we take into account a number of factors, including:

- **Security** – mechanisms allowing to process and store data
- **Scalability** – increasing computing power at any time, depending on the load
- **Monitoring** – active tracking of user activity and processes
- **High availability** – service level agreement
- **System lifecycle management** – support during the product's operational use, its further development, reviews, control, and, as agreed, withdrawal at the end of the lifecycle
- **Compliance with legal requirements and regulations** – knowledge of the guidelines for the process of validation of computerized systems (CSV – Computerized System Validation) and documentation requirements in the process of implementing the solution (Validation Plan, URS, FS, DS, Validation Report) and the required functionalities (Audit Trails, ERES)
- **Best industry practices** (GAMP, IEC 62366) – product categorization based on the intended application and complexity of the chosen solution model
